



ADHHA JACKPOT FUTURITY RULES 2025



The ADHHA Jackpot Futurity is a Limited Breeders stake for Weanlings In-Hand and Three-Year-Olds In Harness with classes held annually at the ADHHA National Championship Finals, and shown in accordance with the ADHHA show rules.

Funding for the Jackpot Futurity is realized from the stallion service Fees donated and sold at the ADHHA Jackpot Futurity Auction. A starting bid of \$500.00 is guaranteed by the stallion donor. All service fees will be sold and there will not be any “no sales.”

NOMINATING THE STALLION:

Stallions of any breed may be nominated to the Jackpot Futurity by donating one service to the auction.

ELIGIBILITY TO THE JACKPOT FUTURITY:

Foal must be registered with ADHHA.

Only two foals per stallion are eligible for the Jackpot Futurity.

- 1). Purchase of a service fee entitles an entry into the Jackpot Futurity.
- 2). The donor of the service fee must pay \$500.00 to have an eligible entrant. Both the auctioned service fees and the \$500.00 fees paid by the donor of the service will fund the Jackpot Futurity classes.

MARE DECLARATION:

MARE DECLARATION: Dams of foals eligible for the Jackpot Futurity must be declared on or before December 31st prior to the year of foaling. If you purchased a service fee at Auction, or if you are the donor and paid your \$500, you can nominate the mare in foal to the stallion the buyer purchased the service fee from. All mares must be owned by buyer, or leased with buyer, with the lease contract turned in at time of nomination. The buyer and donor (*if \$500 is paid*) can enter resulting foal from nominated mare. Selling a service that has been purchased or donated is allowed but information must be submitted in writing to ADHHA detailing that the transaction took place.

Mares which do not get in foal or produce a live foal for the Jackpot are not eligible to enter the Jackpot the following year, without having purchased a stallion service for that year. A return privilege is encouraged, but agreement is solely between mare and stallion owners.

DISTRIBUTION OF PRIZE MONEY:

Each year, 60% of the Jackpot Futurity fund will be paid in the Weanling class. The remaining 40% will be paid to the Three-Year-Old Jackpot Futurity Harness class when these eligible weanlings become of age. Payouts will be for 1st thru 6th place with respective percentage payout of 35%, 25%, 15%, 10%, 8%, 7%.

To encourage stallion owners to donate a service, 20% of all the prize money won by the entrants in the Jackpot Futurity Classes will go to the donor of the stallion whose offspring place 1st thru 6th.

Prize money distribution and classes may be modified upon agreement by ADHHA Board of Directors.
